Whistleblower Protection Improvement Passes Congress

"Legislation to protect whistleblowers in federal agencies has passed both houses of Congress and is heading to President Obama's desk for his signature. The Whistleblower Protection Enhancement Act, which improves protections for federal employees who call attention to waste, fraud and abuse within their agencies, passed the Senate on Nov. 13. Sen. Daniel Akaka (D-Hawaii), the bill's main sponsor, expressed his satisfaction at seeing the bill pass just before his planned retirement from the Senate in January.

'I have worked on this legislation for over a decade, most recently as chairman of the federal workforce subcommittee, and I truly thank my colleagues for enacting this important legislation at this time,' Akaka said in a written statement. The bill, introduced by Akaka in April 2011, had originally passed the Senate in May 2012. The House approved the bill with minor modifications in late September; the Senate then passed the revised measure by unanimous consent.

The bill clarifies that whistleblowers may disclose evidence of censorship of scientific or technical information under the same standards that apply to disclosures of other kinds of waste, fraud, and abuse, and codifies the anti-gag provision that has been part of every Transportation-Treasury Appropriations bill since 1988.

With Counterfeit Components, Buyer Beware

"A <u>2012 study</u> by market research firm IHS found that more than 12 million counterfeit electronics and semiconductor components have entered the distribution chain since 2007, with 57 percent of all counterfeit parts obsolete or end-of-life components.

Many of these parts make their way into mission-critical industries, such as defense and aerospace, where a malfunctioning counterfeit part can mean the difference between life and death. Additional research from IHS noted that suppliers labeled by the US government as "high risk" are increasing their sales to federal agencies -- their presence in the government's supply chain has soared by 63 percent over the past decade.

With the increase of counterfeit electronics in the distribution chain, it is clear that many of these high-risk suppliers are employing increasingly sophisticated techniques to pass off fake components, and many engineers and procurement professionals are unaware that they are being taken advantage of.

This article is the first in a series that examines the growing problem of counterfeit components in the electronics supply chain and how buyers can educate and protect themselves by recognizing fakes and dealing only with manufacturerauthorized distributors."

Alan Rither joined Battelle at the Pacific Northwest National Laboratory in 1973, shortly after graduating from the University of Washington law school. He became a Certified Professional Contracts Manager by the National Contract Management Association (NCMA) in 1976, and was elected a Fellow of the NCMA in 1997.

In 1985, he moved into the Legal Department where he now serves as an Assistant General Counsel. He provides legal advice on contractual matters, business ethics, export control, human subjects research, and a variety of national security issues.

He is co-founder and past national Chair of the Department of Energy's Export Control Coordinators Organization and Vice-Chair of PNNL's Institutional Review Board for Human Subjects Research. He is the past Chair of the International Practice Section of the Washington State Bar Association. He taught accredited courses on Government Contract Law for Columbia Basin College as an adjunct faculty member.

In addition to his professional activities, he is active and holds positions in the Alliance for the Advancement of Science through Astronomy (AASTA), the Richland Public Library Foundation, and other community organizations.
